It was decided to hold the annual meeting at 7:30 p.m. Friday, October 3 in Billings, Montana. A dinner meeting will be held. No main speaker will be on the meeting's agenda.

SALE RULES ADOPTED:

1. Classes and ages of sheep allowed to be sold in the Sale: Stud Rams, Range Rams, Stud Ewes, and Flock Registered Ewes. Rams, both Stud and Range, must be born after January 1, 1968 and the second set of incisor teeth must not touch the pad at the time of the Sale Sifting Committee's inspection. Individual Rams not meeting these requirements will be rejected from the Sale.

No ewes over 4 years of age will be allowed in the Sale.

- 2. Rams and Ewes may be presented for either flock or stud registration at the time they are unloaded at the Sale destination, but each consignor is urged to have his sheep registered prior to their arrival in Billings.

 - 2. Any sheep with any deviation of incisor teeth behind the dental plate will be rejected.
 - B. All rams shall have two normal testicles.
 - C. All rams shall be free of any sign of infection on the penis and sheath of penis.
 - D. All rams and ewes must have two normal eyes and eyes must be free of infection.
 - E. All rams and ewes must have four (4) normal feet and legs free of disease.
 - F. Any major conformation defects will be cause for rejection. Consigned animals below normal size for age or out of condition shall be rejected from the Sale.
- 5. Each consignor shall have the right to one bid on each lot providing bid is placed with auctioneer prior to the time a lot enters the ring.

- 6. The decision of the Sifting Committee, including the Veterinarian, is FINAL.
- 7. All vaccination and/or dipping and/or spraying requirements as outlined by the Montana State Veterinarian shall be complied with.
- 8. It was recommended by the Board of Directors that sheep entered for the Sale be not overly fitted.
- 9. Consignors are to be at the pens of their entries at the time of inspection and branding.

John Paugh is to work with the personnel at the Montana Wool Lab, MSU, on the possibility of some wool judging and/or demonstrations on wool fleeces. Dr. Donald Price said there might be some fleece samples available at the U.S. Sheep Station.

It was agreed that the policy regarding trophies and rosettes at Fairs, as established in the past, be continued for 1969.

There being no further business it was moved by Wilson, seconded by Paugh, that the meeting be adjourned. Carried unanimously. 5:00 p.m.

The meeting was followed by dinner provided by the President and hosts, Mr. and Mrs. Lawrence Capra.

- E. All rams and ewes must have four (4) normal feet and legs free of disease.
- F. Any major conformation defects will be cause for rejection. Consigned animals below normal size for age or out of condition shall be rejected from the Sale.
- 5. Each consignor shall have the right to one bid on each lot providing bid is placed with auctioneer prior to the time a lot enters the ring.
- 6. The decision of the Sifting Committee, including the Veterinarian, is FINAL.
- 7. All vaccination and/or dipping and/or spraying requirements as outlined by the Montana State Veterinarian shall be complied with.

Meeting adjourned at 11:20 p.m.

(Sheep to be consigned as yearlings to the 1967 Sale must be born after January 1, 1966). Motion carried unanimously.

MINUTES OF MEETING OF BOARD OF DIRECTORS U.S. TARGHEE SHEEP ASSOCIATION September 18, 1964

The Board of Directors' meeting of the U.S. Targhee Sheep Association was called to order by President Robert Sutton in the Billings, Montana Chamber of Commerce Building immediately after the annual Association meeting was adjourned September 18, 1964.

Directors present: Robert Sutton, President; Dr. H. E. Furgeson, Vice-President, Leonard Wilson; Arvid Larson, Leo Pfister, and Dr. Robert L. Blackwell, Ex-Officio member of the Board.

Moved by Dr. H. E. Furgeson and seconded by Leo Pfister that the minutes of the previous Board meetings be accepted and that their reading be dispensed with. Carried.

In line with the Constitutional change passed at the Association meeting this date, regarding closing the books, it was moved by Dr. H. E. Furgeson and seconded by Leo Pfister that the U.S. Sheep Station at Dubois, Idaho be allowed to continue with the same procedure for registration as outlined in a letter of September 15, 1952 written by the Secretary of the U.S. Targhee Sheep Association to the Director of the U.S. Sheep Experiment Station, Dubois, Idaho. Carried. (In essence "The Association grants the Dubois Sheep Station the privilege of maintaining Targhee flocks without each individual sheep being registered, and provides that individual sheep that are elegible on the basis of pedigree and those passing inspection when sold be registered in the stud registry in the name of the buyer or new owner at the time of sale.) This entire statement entitled "Registration Procedures - U.S. Sheep Experiment Station" is an official part of these Directors' minutes and will be filed with the records of the Association.

It was suggested that a plan to eliminate a certain percentage of consignors of low selling rams at the Sale be developed for future sales. Nothing definite was done.

It was suggested the Secretary send a copy of the new brochures to County Agents and Vo-Ag Instructors so they may become better acquainted with the breed and its characteristics particularly from a judging stand-point.

Names of possible new inspectors are: Mel Lynch, County Agent at Gillette, Wyoming; and Ken Faulkner, Extension Sheep Specialist, University of Wyoming, Laramie, Wyoming.

Advertising was discussed briefly with no changes suggested.

Motion by Leo Pfister and seconded by Leonard Wilson that out of pocket expenses of Directors incurred resulting from Board meetings be patd by the Association. Carried. Motion by Dr. H. E. Furgeson and

seconded by Leo Pfister that Gene Coombs receive a fee of \$125.00 monthly for his services as Secretary-Treasurer of this Association for the ensuing year. Carried.

There being no further business the meeting was declared adjourned.


REGISTRATION PROCEDURES - U. S. SHEEP EXPERIMENT STATION -

Targhee

- 1. The U. S. Targhee Sheep Association has granted the U. S. Sheep Experiment Station the privilege of maintaining Targhee flocks without each individual sheep being registered, and provides that individual sheep that are eligible on the basis of pedigree and those passing inspection when sold be registered in the stud registry in the name of the buyer or new owner at the time of sale.
- 2. (A) Eligibility of Station sheep for registration as required by the U. S. Targhee Sheep Association Board of Directors be determined as follows (quote from September 15, 1952 letter from William J. Boylan, Association Secretary to Mr. J. E. Nordby, Director of the U. S. Sheep Experiment Station): "It was agreed that the U. S. Sheep Experiment Station would follow the regulations of the Association for their sale rams. The group went on record as accepting the three men* so suggested as an inspection committee responsible to the Association. It was further stated that third-cross rams would be eligible for stud registration and the includes the U. S. Sheep Experiment Station, State Experiment Stations, and breeders. Third-cross ewes from the U. S. Sheep Experiment Station will be eligible for stud registration." The following is a further quotation from those minutes and is a statement by Mr. Hughes: "We hereby go on record as stating that rams with two crosses or more of Targhee breeding proven superior by progeny test with a minimum comparison of two other rams under the same environmental conditions and ewe stock would be eligible for registration in the stud registry."
 - * The above suggested men for the inspection committee were: Mr. K. R. Frederiksen, University of Idaho; Mr. J. A. Stoehr; and the Director of the U. S. Sheep Experiment Station.
 - (B) Eliqibility for registry on the basis of pedigree is determined by checking the pedigree of each sheep on the individual record card. In order to be eligible for registry the extended pedigree of each sheep should show as follows:
 - (1) Sire side of pedigree The sire of the individual animal considered for registration must be of the known "T" eartag series and the grandsire be of known "T" or "T;" eartag series. The extended pedigree must show known ancestors through the last three generations.
 - (2) Dam side of pedigree The Individual animal being considered for registry must have a dam of at least "T" or "T₁" eartag series and the extended pedigree must show known ancestors through the last three generations.
- 3. Some of the sheep in the Targhee flock may be on the borderline for eligibility when the pedigree is extended. Such animals would be those that are offspring of "T₁" sires and "T₁" dams or of "T₁" sires and "T" dams. An example of a borderline case is as follows:

grouping of sheep purchased indicating these sheep to be registered in the name of the buyer. Example: "To be registered in the name of John Doe, Midtown, U.S.A."

- (C) The information in (A) above should be checked against the Station lambing book (for the year of birth of each animal involved) to make certain date of birth, sex, type of birth, sire, and dam are correctly listed. After being checked this information should be typewritten on the Association application for inspection form (in duplicate).
- (D) The original copy of the completed application for registry form should be submitted to: Secretary, U. S. Targhee Sheep Association.
- 9. When completed certificates are returned to the Station, all information should again be checked against lambing book and original check sheet for accuracy. Certificates containing errors should be returned to the Association for correction.
- 10. After information on certificates is determined to be correct, the following information should be listed in the Station Targhee Registration Record Book: Registration Number (in numerical order), Flock Number, Sex, Name and Address of Buyer, and Date of Sale.
- 11. Certificates are then transmitted to respective buyers or new owners.



The Targhee Registration Inspection Committee should decide whether or not borderline individuals should be registered.

- 4. Any animal with a "Ti" eartag series, i.e., first-cross Targhees or animals of "T" eartag series with unknown ancestors in the second generation will not be eligible for registry.
- 5. For convenience of determining registration eligibility, the individual record card and IBM inventory card for sheep born in 1956 and earlier were marked indicating eligibility as follows:
 - (A) Individual Record Card (written in upper right-hand corner) Eligible,
 Borderline, or Ineligible
 - (B) IBM Inventory Card (punched in column 16 and end printed in eighth position, line one of printer) Code 1 Eligible, Code 2 Borderline, Code 3 Ineligible
- 6. After culling of ewe and ram lambs each fail, pedigrees of all Targhee lambs saved for use at the Station should be checked (as per 2-B above) and individual record and IBM inventory cards should be marked for eligibility (as per 5 above).
- 7. (A) Targhee sheep eligible for registry on the basis of pedigree must also be approved for registry by an inspection committee comprised of three staff members from the U. S. Sheep Experiment Station which are designated and approved by the U. S. Targhee Sheep Association. The inspection should be conducted as required by the Association.
 - (B) The inspection committee should place a U. S. Targhee Sheep Association registration eartag and tattoo in the right ear of sheep passing inspection for registry and make a record showing flock and registration eartag numbers of animals involved. (This may be accomplished by writing registration eartag number on end of IBM inventory card.)
- 8. (A) After the annual Station auction sale a sheet should be made up by hand indicating all information to be included on the U.S. Targhee Sheep Association application for inspection form. This information is as follows:

BOARD OF DIRECTORS' MEETING U.S. TARGHEE SHEEP ASSOCIATION Billings, Montana April 3 & 4, 1964

The meeting was called to order at the Gene Coombs' home at 3:00 p.m. Friday, April 3, by President Bob Sutton.

Present: Bob Sutton, Arvid Larson, Dr. H. E. Furgeson, Leo Pfister, and Gene Coombs.

Minutes of the special board meeting of January 24, Board Meeting of October 2, 1963 and regular meeting of October 4, 1963 were read and approved as presented.

Treasurer's report from October 1, 1963 to April 1, 1964 was given. Moved by Dr. Furgeson and seconded by Pfister that report be approved as read. Carried.

Copy for the brochure was discussed and approved for final printing. Copy as officially approved accompanies these minutes in the official books of this Association. Brochure cover picture was next discussed. Moved by Dr. Furgeson, seconded by Larson, that the picture accompanying these official minutes in the Books of the Association be on the cover of the brochure. Carried.

Triplet picture in the brochure was next on the agenda. Moved by Dr. Furgeson, seconded by Pfister, that Herman Huisenga of Huisenga Advertising chose the best picture for the brochure (the picture which accompanies these official minutes in the Books of this Association was selected jointly by Huisenga and the Board).

It was moved by Dr. Furgeson and seconded by Larson that the annual Association Sale shall be held Saturday, September 19, 1964 in Billings, Montana.

The meeting was adjourned at 11:30 p.m. April 3, 1964 to be called to order at 9:15 a.m. Saturday, April 4, 1964 in the Hunter's Room of the Billings Chamber of Commerce Building. Present were same as the previous meeting plus Herman Huisenga of Huisenga Advertising Co. Discussion with Huisenga was centered around the brochure, brochure pictures, decals for gates and pick-up doors, and magazine advertising. Huisenga said the copy of the brochure should be ready for the Directors' final approval within two weeks.

It was moved by Dr. Furgeson and seconded by Pfister that 5000 copies of the brochure be printed as well as 5000 copies be printed of Targhee Standards and Rules of Registration and Entry which would have the same cover as the brochure. Carried.

Included with the brochure and other normal mailing pieces will be a notice of the 1964 annual Sale which will be printed on new letterheads.

The Secretary is to write James Bassett, an official inspector, of Texas ARM, formerly of Montana State College, and invite him to be the official inspector in the Texas and adjoining areas.

The Secretary is to contact J.L. VanHorn of Montana State College and find out if there are ony other activities at the college in June or July which could fit in with an inspectors' school. A Directors' meeting may also be called at that time in Bozeman.

The following are motions and other activities discussed in regards to the annual Sele which will be held in Billings, Saturday, September 19, 1964:

1. Moved by Dr. Furgeson, seconded by Pfister, that the annual Sale be held at Billings Livestock Commission Co. Carried. (Furgeson and Pfister voted yes--Larson--voted no). Charges will be \$1.50 per head.

2.Classes and ages of sheep allowed at Sale. Flock and Stud Registered Rams and Stud and Flock Registered Ewes. It was moved by Dr. Furgeson and seconded by Larson that all Range Rams consigned to annual Sale be Flock Registered. It was moved by Dr. Furgeson and seconded by Larson that only yearling rams be accepted for the Sale and that no ram could be consigned that was born before December 1, 1962 and that any ram having two pair of solid incisor teeth would not be allowed in the Sale. Carried.

It was moved by Dr. Hurgeson and seconded by Pfister that no ewes over five years of age be allowed in the Sale. Carried.

3.Rams and ewes may be presented for either flock or stud registration at the time they are unloaded at the Sale destination, but each consignor is urged to have his sheep registered prior to their arrival in Billings.

4. Moved by Dr. Furgeon and seconded by Pfister that any registered sheep entered for the Sale shall not be revoked by the sifting committee on official Targhee Registry Standards. Carried.

5. The following Sifting Committee Sale Standards were adopted:

- A. Bad Mouth
 - 1. If cutting edges of incisor teeth can be felt shead of the dental pad, the sheep will be rejected.
 2. Any sheep with any deviation of incisor teeth behind the dental plate will be rejected.
- B. All rams shall have two normal testicles.
- C. All rams shall be free of any sign of infection on the penis and sheath of penis.
- D. All rams and ewes must have two normal eyes and eyes must be free of infection.
- E. All rams and ewes must have four (4) normal feet and legs free of disease.
- F. Any major conformation defects will be cause for rejection. Consigned animals below normal size for age or out of condition shall be rejected from the Sale.

6.All sheep consigned to the Sale must be Blue Tongue vaccinated not less than two weeks prior nor longer than 60 days prior to the Sale. (SEE STATEMENT AT END OF MINUTES.)

7. All sheep consigned to the Sale must be dipped or sprayed by of a veterinari-(Recommended time for spraying is not less than two weeks nor more than 60 days prior to the Sale). (SEE STATEMENT AT END OF MINUTES.)

8. Each consignor shall have the right to one bid on each lot providing bid is placed with auctioneer prior to the time a lot enters the ring.

9. The decision of the Sifting Committee, including the Veterinarian, is final. It was moved by Dr. Furgeson and seconded by Larson that the above set of Sale rules be adopted in full. Carried. Suggested Sifting Committee was:

1. one member from the Dubois Station 2. one member from the Wool Laboratory at Montana State Correct

3. George E. Stanley

5. veterinarian be from the Montana Livestock Sanitary Board (Dr. Glenn Halver was suggested) or other vet. from Montana State College.

Sale Committee will be --- The Directors. Sale Manager will be Arvid Larson. Sale Auctioneer will be Tige Thomas. July 20 will be the deadline for entries for the Sale to be in. Entry fee must accompany the entries and all entry fees shall be forfeited except for Sifting Committee rejects.

The 1964 annual meeting will be held Friday evening, September 18 and J.L. VanHorn will be asked to present his slide lecture on the sheep business in Austrailia.

Next item of discussion was with regard to trophies at fairs. The following policy was adopted: No trophies will be awarded unless there are at least six entries. in a class with no more etter sheep belonging to any one exhibitor. Limit of trophies shall be limited to two trophies per show. Those being for (a) Champion Targhee Ewe and (b) Champion Targhee Ram. The Secretary was requested to purchase trophies in wholesale lots and send them upon request to various shows and fairs.

It was moved by Dr. Furgeson and seconded by Pfister that the Books of the U.S. Targhee Sheep Association shall be closed as of October 1, 1966, but shall be left open for entry of further blood lines by the U.S. Sheep Experiment Station, Dubois, Idaho, or any other official Experiment Station at the discretion of the Board of Directors of this Association. Furthermore any lambs registered subsequent to October 1, 1966 shall be progeny of either Flock or Stud registered Targhee sheep. Motion carried.

It was moved by Dr. Furgeon and seconded by Larson that the vote on this constitutional change be presented before the membership of this Association during its annual meeting, September 18, 1964.

There being no further business the meeting adjourned at 4:45 p.m.

The following is an direct quote from a letter received from Dr. J.W. Safford, State Veterinarian of Montana, regarding sheep scabies and Blue-Tongue in sheep: "sheep scabies exists in Nebraska; therefore, the dipping requirements specified in Regulation 1521 (sheep shall be dipped under state or federal supervision in a wettable benzene hexachloride (BHC) or lindane solution containing gamma isomer concentrate of not less than 0.00 per cent within ten (10) days prior to date of importation) will have to be met on any sheep originating from Nebraska, and a permit will have to be obtained from this office to ship the sheep into Montana. Scabies is not presently reported from other states listed in your letter.

Bluetongue in sheep has been reported in all states you list, therefore, the sheep originating from these states must obtain a permit from this office before shipment. A permit will be granted provided the sheep are accompanied with an official health certificate certifying that the sheep originate from a flock free of bluetongue, the sheep have been vaccinated against bluetongue at least thirty (30) days before entry into Montana, and the sheep have been officially dipped within seven (7) days prior to entry into Montana." (Dr. Safford's letter written May 8, 1964).

States referred to in Dr. Safford's letter are Nebraska, North and South Dakota, Wyoming, Idaho, and California.

Present: Robert Sutton, Dr. H.E. Ferguson, Arvid Larson, Curtis Hughes, Gene Coombs and Herman Huisenga.


It was moved by Dr. H.E. Ferguson that the Targhee brochure be re-done in its entirety. Seconded by Arvid Larson. Carried unanimously.

THIS WILL INSURE A CONTINUAL SUPPLY OF GOOD REGISTERED STOCK FOR BOTH THE MEMBER HIMSELF AND AFFORDS THE EXTRA INCENTIVE OF BEING ABLE TO SELL REGISTERED TARGHEES WHICH, IN THE END, SHOULD RESULT IN MORE REGISTERED TARGHEES BEING SOLD, AND IT WILL MAKE THE JOB OF A CONTINUAL REGISTRATION PROCESS AND FLOCK UP-GRADING PROCESS EASIER AND BETTER FOR ALL MEMBERS.

It was moved by Warren Johnson and seconded by Arvid Larson that George Stanley of California be approved as an official inspector. Carried.

MINUTES OF MEETING OF BOARD OF DIRECTORS U.S. Targhee Sheep Association

June 15, 1963

The mid-year meeting of the Directors of the U.S. Targhee Sheep Association was called to order Saturday, June 15, 1963 at 9:00 A.M. by President Bob Sutton in the Hunters' Room of the Billings Chamber of Commerce Building.

Directors present: Bob Sutton, Leo Pfister, Warren Johnson, and Arvid Larson. Others present: J. L. VanHorn, Curtis Hughes, Herman Huisenga, and Gene Coombs, Secretary-Treasurer.

The Secretary read the minutes of the annual meeting of October 5, 1962 as well as the minutes of the Directors' meeting of October 5, 1962. These minutes were accepted as read. A financial report as of June 10, 1963 was accepted as presented.

The Secretary reported that five new members had joined the Association since the 1962 annual meeting.

As a new brochure was given the number one priority for this year at the Directors' meeting lastfall Herman Huisenga of Huisenga Advertising Agency met with the brochure committee, composed of Warren Johnson, Curt Hughes, and J. L. VanHorn, as well as with the Board. After presenting the preliminary lay-out of the brochure the committee met with Mr. Huisenga the balance of the day in working out the final details on the brochure. It is hoped the brochure can be out by August 1st. It was moved by Pfister and seconded by Larson that the Secretary work out with Mr. Huisenga a more effective Advertising program for the Association for the balance of the year and, if necessary, increase the amount spent for advertising up to an additional 20 per cent.

The next subject of discussion was the Annual National Targhee Sale.

- 1. The annual Sale will be held Saturday, October 5, 1963.
- 2. After meeting with the representatives of both the Billings Livestock Commission Company and the Public Livestock Marketing Center it was moved by Larson that the Sale be held at the Public Livestock Market Center. Motion seconded and carried. Their only charge will be 50¢ per head and they will advertise the Sale in all their announcements in all forms of their advertising.
- 3. Sifting Committee will be composed of N. A. Jacobsen, A. V. Edsall, and Henry Yoppee. In addition, a veterinarian will be asked to inspect sheep entered in the Sale for health factors only. (A member of the Dubois staff will be invited as a substitute on the Sifting Committee).
- 4. The Sale Committee will consist of Curtis Hughes, Arvid Larson, and Olan Willis.
 - 5. Arvid Larson will act as Sale Manager.

- 6. The Following Classes will be accepted for the 1963 Sale:
 - A. Stud Ewes
 - B. Stud Rams (Yearling and 2 year olds)
 - C. Flock Registered Ewes
 - D. Range Rams (Yearlings and 2 year olds)
- 7. No sheep will be allowed to be entered if over 5 years old. Preference will be given to younger sheep if reduction in numbers for the Sale if necessary after Sale entries are in.
- 8. The following were the maximum number of sheep suggested for the Sale in the various classes:
 - A. Stud Rams one (1) per member
 - B. Range Rams Number open
 - C. Stud Ewes Number open
 - D. Flock Registered Ewes Number open
- 9. Entry fees on all sheep accepted for the Sale will be retained by the Association.
- 10. Entry fees <u>must</u> accompany the entry blanks. Fees on sheep not accepted by the Sale Committee will be refunded to the member.
- ll. No sheep that are sifted will be allowed to be sold until after the Sale.
 - 12. Entry fees will be as follows:
 - A. Stud Rams \$25.00 per head
- B. Stud Ewes \$5.00 per head up to 4 head \$4.00 per head in pens of 5 head or more.
- C. Flock Registered Ewes \$4.00 per head in pens up to 4 head \$3.00 per head in pens of 5 head or more.
 - D. Range Rams \$5.00 per head.
- 13. Deadline for Sale Entries to be in to the Secretary August 5, 1963.
 - 14. Auctioneer Ken Thompson
 - 15. Advertising commensurate with the prevailing situation.
- 16. Moved by Larson, seconded by Pfister, that bona fide 4-H and FFA members will be eligible to consign to the Sale whether a member of the Association or not. Carried.
- 17. Moved by Pfister, seconded by Larson, that checks to consignors of the Sale will be withheld by the Secretary until all registration certificates and transfers have been received by the Secretary and properly recorded in the official records of the Association. Motion carried.
