Election of Board of Directors



USDA Announces Coronavirus Food Assistance Program

USDA is taking applications for the Coronavirus Food Assistance Program until August 15th. As part of applying for the program, you'll need to contact the Farm Service Agency county office at your local USDA Service Center to schedule an appointment. Find your office at http:// farmers.gov/cfap.

Sheep producers are looking at payments of \$33 per head for lambs and yearlings that were marketed between Jan. 15 and April 15 of this year. That number is \$7 per head for lambs and yearlings in inventory on hand between April 15 and May 4.

Possible By-Law Amendment

In 2019, the board of directors from the USTSA was made aware of a practice going on during previous years, which was the practice of "granting" registration numbers to animals coming from U.S. Sheep Experiment Station (Dubois) from whose parents were not registered. This seemed to go against the long-standing belief, and quoting from the history of the Targhee Sheep written by Jack McRae, "In 1966, the books of the association were closed and since that time registered Targhees must be from registered parents."

The board was presented with a copy of a 1964 document that went into the association-operating document of that time, the USTSA constitution, which allowed this practice. The document stated:

"The books of the U.S. Targhee Sheep Association shall be closed as of October 1, 1966, but shall be left open for entry of further bloodlines by the U.S. Sheep Experiment Station, Dubois, Idaho, or any other official Experiment Station at the discretion of the Board of Directors of this association. Furthermore, any lambs registered subsequent to October 1, 1966 shall be progeny of either flock or stud registered Targhee sheep."

Based upon that document, under the assumption that our constitution was still a practicing document, and working with the manager at Dubois, the board voted to approve the following rules regarding the registration of unregistered animals coming out of the Dubois Targhee flock, in order to ensure the integrity of our registration process:

- 1) The buyer will provide the fees to register that animal, it's sire, and it's dam.
- 2) The registration information for all involved animals will be pulled from the NSIP database.
- 3) The USTSA will inform the Dubois Research Station of the details regarding that registration (to facilitate the recording of that information into their database).
- 4) In agreement with the Dubois Research Station, any animal they offer for sale that comes from a non-registrable bloodline (i.e. from lineages that contain animals brought into Dubois which were not registered), and in turn will not be registrable with the USTSA, will be marked in their records and be noted to the seller prior to sale.

Since that time, it has been made known to the Board of Directors that the old USTSA constitution no long exists, meaning it has been replaced by our current operating by-laws. Thus, our initial assumption that the 1964 document allowing this practice was still in our current operating document was flawed, which in turn may place the status of our vote into question.

To allow this practice, our by-laws will need to be changed. If the membership of the USTSA would desire this practice to be implemented, a motion would need to be brought before the membership during our special meeting being held in July 2020 asking for this procedure, or another procedure modified during discussions. If a 2/3 majority approves that motion, it will be brought to the 2021 USTSA National Meeting for final approval with another 2/3-majority vote.

Registration process in the USTSA

For discussion and possible amendment at the Special Meeting of the Membership on July 20, 2020.

Article II Section 2 of the US Targhee Sheep Association By-laws as amended July 2004 states: "The Association shall register and keep on file all records of registration and transfers of the Targhee breed in the United States. It shall receive and disburse the finances of the organization."

There has been much discussion about the possibility of "outsourcing" the registration process under a contract with an outside firm specializing in such processes. In January, the USTSA Board of Directors submitted to the membership a paper ballot requesting a vote on who would be in favor of outsourcing registrations. Subsequently, a protest of the vote was made because the vote had to be at an annual meeting since it had already been an agenda item at the previous annual meeting and was tabled for further research and discussion. Also subsequently, the question was raised as to whether such outsourcing of the registration process required a change in the Bylaws as noted above.

The Association owns the database of registrations whether the actual work is done by contract with the Secretary-Treasurer (as currently) or by contract with an outside firm. All information shall be kept on file with the Association. Article II Section 2 does not specify by whom the work must be performed. Article VII Section 5 Duties of the Secretary/Treasurer does not stipulate that the registration process is the responsibility of the Secretary/Treasurer. The Board of Directors has been given the authority to enter into contracts required to conduct the business of the Association.

Article VIII Amendments of the By-Laws states: "These By-Laws may be amended at any Annual Meeting provided, however, that notice of the intention to amend these By-Laws and the substance of such amendment have been submitted to each active member of the Association by mail twenty (20) days prior to such meeting. The approval of two-thirds of the members present and those voting by proxy shall be required for adoption of any amendment."

It has been the past practice of the Association under Roberts Rules of Order to require a vote at two annual meetings for a Bylaw change to be passed. If a Bylaw change is required, there would have to be another 2/3 majority vote at the annual meeting in 2021 before the change would be effective.

If a Bylaw change is not required as per this membership vote, this decision could be reversed/counter-reversed at a future meeting by a simple majority vote. Based upon questions that have been asked, please see the attached FAQS regarding outsourcing.

The questions before the membership are thus:

Do the Bylaws need to be amended to allow outsourcing of the registration process? Are you in favor of outsourcing of the registration process?

FAQS regarding outsourcing of USTSA Registrations

- 1. Who would be contracted for the registration process? What is the cost to the USTSA? Associated Registry (www.associatedregistry.com) was contacted by Todd Taylor for information on their process. Many other breeds are currently using their services successfully. A copy of our current database was shared with Jeff Ebert, their director. He responded that our database could probably be converted at a cost of approximately \$1600. Their fee is \$3.40 per transaction. There is no annual fee or extra cost to access the database. They would have a five year contract with no price increase. They would design a group registration certificate at no cost to fit our needs.
- 2. Who owns the database, what is the format and what are the rules for access? Who retains accountability?
 - According to an email from Jeff Ebert in response to these questions: "The USTSA owns the database. We can provide a copy of the database in Excel format as often as you like as long as that is a reasonable time period. I would recommend quarterly if that is so desired. No cost to have access. The database is a unique program that is backed up by us but also by a host cloud based company in two different locations. Public Access- We work with Doug Meyer and provide data to him. This is something USTSA would contract separately with Doug. Doug is very reasonable. \$1000 to set up and \$60 per month. Other associations are much less monthly. We provide the data in periodic data dumps as pre-determined by the associations at no cost. Accountability- As we all know animal registrations rely greatly on breeder integrity. We will follow whatever rules are provided by the USTSA for the registration process."
- 3. What will happen to the Secretary/Treasurer position if the registration process is outsourced?
 - Mardy's contract is for \$450 per month plus \$50 for reimbursed expenses, a total of \$6000. She is not required to keep time sheets but she estimates her total hours at 631 per year of which she estimates 240 hours is spent on registrations. The balance of her time is spent on the National Show, bookkeeping, responding to inquiries, board communications and other admin duties. Her hourly rate is thus about \$8.56 or close to minimum wage. If USTSA retains an oversight/accountability function, Mardy would still have hours for registration though reduced. Per Board discussion, her contract amount would not be reduced. Even if she had no hours for registration, her hourly rate would be \$13.81. Her time could be spent on other promotional activities.
- 4. Can we afford to outsource?
 - The proposal was to increase registration fees by \$1.00. The 2018 registration number was 916. The highest prior registration numbers were 1690 in 1997 and 1606 in 2005. Otherwise they have been running around the 1000 mark. The association has savings that could be used for the start up fees. The \$1.00 increase in registration would not cover the cost of the \$3.40 per transaction fee for outsourcing. The hope is that by outsourcing the number of registrations would increase to cover the additional cost. Registration revenue in 2018 was about \$4600. If the numbers do not increase as hoped, the registration fee would have to be reevaluated. USTSA dues and registration fees are below other breeds, which you can compare on the Associated Registry website.
- 5. I participate in NSIP and maintain my pedigrees on that database. Why should I register? NSIP is a valuable tool to producers but it does not replace registration. NSIP pedigree info is not 3rd party validated. Registration is validated by a 3rd party and also proves ownership of animals.

Wool LDP Now Available

As the wool market struggles during the current worldwide pandemic, now might be a good time for wool producers to look into the Farm Service Agency's Wool Loan Deficiency Payment Program.

Just this week, LDP payments were available for fine wool (finer than 18.6 micron), as well as coarse wool (ranging from 26 micron and up). Payment rates change weekly, but wool finer than 18.6 micron was eligible for a 35 cent per pound payment this week. Wool from 26 to 28.9 micron was eligible for a 23 cent per pound payment and wool 29 micron and coarser was eligible for a 30 cent per pound payment.


"Wools have been going into storage so we understand there is now an interest in the loan function of this program and we met with USDA's Farm Service Agency to share the latest information plus review options for loans with or without objective measurement tests," said ASI Executive Director Peter Orwick. "It has been more than a decade since loans or the deficiency payments were used widely, so it is a good idea that the agency coordinate information across its offices and with sheep producers. We must work together to maximize use of this program. It is imperative that the entire wool industry – from buyers to warehouses to producers - share prices of wool sold to USDA's Agricultural Marketing Service."

More Opportunities to Show Fleeces & Cultivate Youth Development Amidst the COVID Pandemic

Since this year's National Show and Sale is canceled, it doesn't mean the fleeces that you have already collected to be shown should just be thrown into next year's bale. The National Western Stock Show has a fleece show that can showcase the "Tremendous" Targhee Fleece.

The National Western wool show is held the first week of January in Denver. Wool can be easily entered online for the show. Additionally, producers are cut a check for their fleeces (generally above market price) and fleeces are eligible for premiums if they do well.

If you're interested in entering wool in the National Western this year, please contact wool superintendent, Jennifer Tucker – (303) 637 – 8157.

The next big hurdle is getting fleeces to Denver. The Sweet Grass County Extension Office, in Big Timber, MT, is collecting fleeces to get them down to Denver at no charge. Their phone number is (406) 932-5146.

Besides being shown, fleeces are then used for the 4-H and Collegiate Wool Judging Contests or auctioned off to 4-H and Collegiate programs. Programs like these have a multiplier effect in developing the next generation of sheep industry advocates and thus are worthy of our support.


